A child in early childhood education is entitled to systematic and goal-oriented education and care, as guaranteed in the Act on Early Childhood Education and Care. For these purposes, an early childhood education plan is drafted for every child in a day care centre or in family day care. The implementation of the child's early childhood education plan must be assessed and revised at least once a year. The plan should also be revised whenever the needs of the child so require. (Act on Early Childhood Education and Care, Section 7a)

The municipality of Siikalatva has introduced the Let's Talk about Children method that includes a discussion where the participants talk through everyday issues concerning the child as regards home, early childhood education, school, hobbies, or leisure. The aim is to reach mutual understanding of issues affecting the child's well-being and daily life. The guardians of children aged 3 and 6 are invited to the discussion and, if necessary, it can also be proposed for children in other age groups at the request of the guardian or an employee. The discussion is voluntary.


